- Overlap with the Agriculture and Rural Affairs, Environmental Resources & Energy, Judiciary, Transportation, and Tourism and Recreational Development Committees on issues dealing with wildlife, farming, law enforcement, and recreational development.
- Receives and reviews annual performance and status reports from the PFBC and the PGC
- Reviews semi-annual reports in conjunction with the Legislative Budget and Finance Committee (LBFC) on fiscal affairs of the PFBC and the PGC.

#### **Constituent Issues**

- Interact with both Commissions in an effort to cut through bureaucratic red tape involving licenses, registrations and matters involving alleged violations of either code
- Respond to member and constituent requests for information on regulatory and legislative initiatives
- Serve as an intermediary between members of the General Assembly and both Commissions and the United States Fish and Wildlife Service.
- Contact with sporting groups, such as the NRA, PA Federation of Sportsmen and Conservationists, Wild Turkey Federation, Trout Unlimited, Back Country Hunters and Anglers, and Congressional Sportsmen's Foundation.
